






EDUCATION



A good education is essential for the future success of our children. Helping them achieve their potential prepares them for life and produces independent, successful adults.

THE GOAL

Create better opportunities for our children to reach their full potential, while providing them with the social support to succeed.

THE NEED

Almost half the children in Etowah County cannot read on grade level and 24% of students do not graduate high school.

THE FOCUS

- Increase the number of children entering kindergarten ready to learn.
- Increase the number of children reading at grade level.
- Youth remain in school and graduate on time.



100% of children who attended Boys & Girls club graduated high school according to statistics



95 children who participated in Kinder Camp were more equipped to start kindergarten

THE RESULTS

Last year, 6,867 children in Etowah County directly benefited from United Way-funded programs in the Education area.



Jalen came to the Boys & Girls Club as a shy, middle-school student. He did not get along with many of our other students. Jalen was reluctant to participate in any other program offerings. Through the help of volunteer, Judge David Kimberley, we were able to include tennis in our program offerings as part of the Triple Play program. Jalen quickly fell in love with the sport. His confidence has improved tremendously. He interacts with other students. He participates in other programs and activities and has received positive reports from school.

FINANCIAL STABILITY



A quality education leads to a stable job that creates enough income to support a family through retirement. Every family needs enough income to pay for the necessities and provide a stable home.

THE GOAL

Help people build a solid financial future so our entire community can flourish.

THE NEED

28% of children in Etowah County live in poverty and 23% of low-income families have less than \$300 in a checking or savings account.

THE FOCUS

- Low-income individuals and families will maximize their income in order to meet daily expenses.
- Low-income individuals and families have mainstream accounts for savings and enough money saved for emergencies.
- Low-income individuals and families will have better financial behavior and break the cycle of poverty.



Gadsden Community Education worked with 13 students who recovered credits allowing them to move up and graduate with their class.

THE RESULTS

Last year, 3,100 clients in Etowah County directly benefited from United Way-funded programs in the Financial Stability area.



Alex had failed several classes due to her attendance. The Gadsden City School's United Way Rep talked to Alex about her attendance and learned her absences were due to taking care of her daughter during the day while Alex's dad worked third shift and was unable to care for the child. The Rep helped Alex enroll in a Second Chance program which allowed her to shift from a traditional classroom setting to a virtual classroom setting. Alex was able to recover several of her classes she had failed. Her attendance increased and she was able to graduate with her classmates.

Health is important to us all and factors into every aspect of our lives. Adults and children who are in good mental and physical health are productive at work and school, and are more likely to give back to their community.

THE GOAL

Create a vibrant and thriving community by promoting physical, social and emotional health for infants, children, adults and seniors.

THE NEED

Over 20,000 residents are uninsured, 14% of Etowah County adults have diabetes and there are 145 teen pregnancies each year.

THE FOCUS

 Increase the number of youth and adults who are healthy and avoid risky behaviors.

THE RESULTS

Last year, 8,867 residents in Etowah County directly benefited from United Way-funded programs in the Health area.



Vicki was diagnosed with breast cancer at the age of 61. She lived alone and was on disability. Soon after starting her treatment she became very ill and Etowah County Home Health Services was brought in to monitor her condition. The Home Health social worker soon realized Vicki was unable to provide for herself. The social worker began collaborating with several partner agencies to meet Vicki's basic needs. MANNA provides her a hot meal five days a week. The Council on Aging assisted her with nutritional supplements and the Etowah Baptist Missions Center provided her with food. This collaboration allowed Vicki to remain in her home safely and improve her quality of life.

Alyssa was a lovely and creative 12 year-old who came to the James M. Barrie Center for a forensic interview. During her interview, Alyssa disclosed that her mother's boyfriend had sexually abused her. She felt guilty for "telling on" the man and blamed herself for the changes that occurred in her family after she disclosed her story. The Barrie Center was able to offer counseling sessions to Alyssa. Over time, she began to understand that the abuse was not her fault and is now able to identify her feelings and work through them. The offender is currently awaiting trial.
